VOTING RESULTS AT ANNUAL GENERAL MEETING HELD ON 27TH MAY, 2005

At the Annual General Meeting of Arts Optical International Holdings Limited (the “Company”) held on 27th May, 2005 (“AGM”), a poll was demanded by the Chairman for voting on all the proposed resolutions as set out in the Notice of AGM dated 28th April, 2005.

As at the date of AGM, the total number of issued shares in the Company was 379,130,000 shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM. There is no restriction on any shareholders casting votes on any of the resolutions at the AGM. No party has stated its intention in the shareholder’s circular of the Company dated 28th April, 2005 that it would vote against any resolution or that it would abstain from voting at the AGM.

The Company’s share registrar in Hong Kong, Secretaries Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The number of shares represented by votes for and against the respective resolutions at the AGM was as follows:
